4. ALECO will hold a Negotiated Conference on May 04, 2026 at 3:00PM at the ALECO Board Room with same address as above.
5. Bidders that have previously purchased bid documents are no longer required to purchase the bid documents again. However, new suppliers who did not purchase the bidding documents in the previous failed biddings may join provided that they shall pay the applicable Bidding Documents fee, not later than the submission of their Best Offer.
6. The bid shall not be considered unless properly signed by the interested bidder or duly authorized representative/s.
7. Online submission should be password protected and such shall only be provided to the BAC Secretary upon opening of bids/negotiation. File sent without password protection shall not be honored.
8. ALECO reserves the right to accept or reject any bid, and to annul the bidding process at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidder.

  - a. Name of the contract
  - b. Date of contract

9. Valid and current Certificate of Accreditation issued by the National Electrification Administration (NEA) as an accredited Health Maintenance Organization (HMO) provider.
