LOCATION OF PREMISE TO RECEIVE ELECTRIC SERVICE (Complete Address) :

The undersigned (hereinafter called the “Applicant”) hereby applies for membership and agrees to purchase power from ALBAY ELECTRIC COOPERATIVE, INC., herein called the COOPERATIVE, INC. and in consideration of acceptance of this application agrees under the following terms and conditions:

1. The APPLICANT shall pay to the Cooperative the sum of FIVE PESOS (Php 5.00) which, if this application is accepted by Cooperative, shall constitute the APPLICANT’s Membership Fee.
2. The APPLICANT will, when electric energy becomes available, purchase from the Cooperative all electric energy to be used on the premises described above and will pay therefore monthly rate to be determined from time to time, in accordance with the By-Laws of the Cooperative.
3. The APPLICANT shall cause his premises to be wired in accordance with the wiring specifications of the Cooperative as mandated by the Philippine Electric Code (RA 7920) and in accordance with the Distribution Services and open Access Rules (DSOAR).
4. The APPLICANT will comply with and be bounded by the provisions of the Articles of Incorporation and By-laws of the Cooperative, and such rules and regulations as may from time to time be adopted by the Cooperative.
5. The APPLICANT grants the Cooperative the necessary right and easements to construct, operate repair and perpetually maintain its line or lines for the transmission and/or distribution of electric energy on the property owned by the Undersigned,thus, hereby executes and delivers to the Cooperative the conveyance, grant or instrument necessary for the above stated purposes or any of them, including clearing of obstructions to ensure the safe and regular flow of electricity. All service lines, switches, meters, appliances and equipment constructed or installed by the Cooperative on the property of the Applicant shall at all times be the sole property of the Cooperative; and the Cooperative shall have all the right to operate, maintain or relocate the said facilities.
6. The applicant shall be jointly and severally liable with the occupant of his/her premises for any unpaid electric bills that left unpaid and shall not perform or do any act prejudicial to the interest of the Cooperative.
7. The Cooperative shall not be liable for damages to the Member/APPLICANT for failure to supply electricity and/or damages to said premise under any conditions.
8. The APPLICANT shall have all the rights and privileges granted to the members under the By-Laws of the Cooperative or any amendment thereto and will comply with and be bound by such By-laws and all laws and regulations, which from time to time may be adopted by the Board of Directors of the Cooperative.
9. The APPLICANT, by paying Membership Fee and becoming a member under the By-Laws assumes no personal liabilities or responsibility for any debts and/or liabilities of the Cooperative. And it is expressly understood that under the law his private property cannot be attached for such debt or liability.
- 10.The acceptance of this application by the Cooperative shall constitute an agreement between the APPLICANT and the Cooperative and the Contract for Electric Service shall continue in force until cancelled within 30 days written notice by either party to the other.
11. That any misrepresentation, dishonesty and falsification in the execution of this application shall be a ground to the disconnection of service even without prior notice and shall be criminally, administratively, and civilly liable in the court of law.
