APPLICATION IS HEREBY made for electric service to be supplied by ALBAY ELECTRIC COOPERATIVE INC. (the cooperative) to be used by me and/or the Company represented in accordance with the terms and conditions of service, and hereby agree:

1. That the APPLICANT/CONSUMER agrees to abide by all the policies, rules, directives, and memorand adopted/approved by the COOPERATIVE's Board of Directors and Management.
2. That the APPLICANT/CONSUMER shall not directly or indirectly transfer his/her rights and obligation under contract to third parties without prior notice and approval of the COOPERATIVE.
3. That the APPLICANT/CONSUMER shall be responsible for the condition and safety of the electrical wirings within his/her dwelling or establishment and he/she shall allow the COOPERATIVE's duly authorized employees/officer to inspect his/her electrical wiring and loads and the COOPERATIVE's kilowatt-hour (kWh) meter at any reasonable time: the APPLICANT/CONSUMER is also responsible for the safety of the kWhm and service drop wire entrusted to his/her custody by the COOPERATIVE; damage to which, if traced to applicant's fault or negligence, shall be consumer's liability to the cooperative.
4. That the APPLICANT/CONSUMER shall pay the cooperative the corresponding amounts for required fees, bill deposit, and/or other charges in accordance with the applicable COOPERATIVE policies.
5. That the COOPERATIVE shall supply all the electrical energy required by the APPLICANT/CONSUMER, and the latter shall pay the COOPERATIVE his/her monthly power consumption and payment of which shall be made not later than the due date indicated in his/her power bill.
6. That the temporary service connection shall be for the duration from _____ to _____ renewable every three (3) months. For any needed changes in the herein specified period, the APPLICATION/CONSUMER shall formally inform the COOPERATIVE when the temporary connection should be disconnected or extended into permanent connection, in which latter case, the APPLICANT/CONSUMER shall comply with all the requirements for permanent connection;
7. That if the APPLICANT/CONSUMER vacates the dwelling/establishment and leaves behind power bill arrears, the COOPERATIVE has the right to charge and integrate the total arrears to any of the APPLICANT/CONSUMER's active connection.
8. That the COOPERATIVE reserves the right to refuse connection on valid grounds, or effect of disconnection of electrical service when the provision hereof are violated or when there is lawful cause to effect disconnection.
9. That the APPLICANT/CONSUMER shall observe all necessary precautions as to his/her temporary electrical system and shall assume solely the responsibility for any incident arising there from;

10. That this contract shall commence on _____ and shall expire upon disconnection or conversion of the subject temporary connection to permanent connection.
