- 5. Only bidders who are able to secure a copy of Bidding Documents from the BAC Secretariat before 1:30 PM on the schedule Pre-Bid Conference shall be allowed to join the said activity.
- 6. Prospective bidders who could not attend the Pre-Bid Conference (date, time and place stated above) may still buy bid documents and join the bidding but queries after Pre-Bid Conference will no longer be entertained.
- 7. Bid proposals must be VAT inclusive. Sealed Eligibility Requirements, Technical, and Financial Envelopes must be submitted to the BAC Secretariat at the address given below, ON or BEFORE the scheduled Bid Opening (Monday, October 28, 2024) until 12:59 PM, during which said envelopes for eligibility requirements and proposal for the respective lots will be opened and read in the presence of the bidder's representative. Late bids shall not be accepted.
- 8. All bids submitted must be accompanied by a bid security, in cash/cashier's check/manager's check issued by a universal/commercial bank. This bid security shall be valid for at least one hundred twenty (120) days, starting from the date of the opening.
- 9. The Albay Electric Cooperative, Inc. (ALECO) hereby reserves the right to reject any and all bids, to award in whole or in part, declare a failure of bidding, or not to award the contract without disclosing any reason, to waive minor defects or infirmities therein, and to accept such bids as may be deemed advantageous to ALECO.
